

Guidelines for:

The Steven Levy and Pat Montalbano ASID NJ Emerging Professionals Scholarship Fund

The Steven Levy and Pat Montalbano ASID NJ Emerging Professionals Scholarship Fund was created to provide Interior Design career-minded individuals the opportunity to develop professionally, civically and socially within New Jersey. Recipients of The Steven Levy and Pat Montalbano ASID NJ Emerging Professionals Scholarship will receive an ASID NJ membership for their first two years upon graduation.

In order to apply for this scholarship, candidate must:

1. Be a 2022 graduating student currently pursuing a Bachelor's Degree of Interior Design from the State of New Jersey.
2. Be 21-years of age or older by September 1, 2021.
3. Have a grade point average of 3.0 or better (on a 4.0 scale).
4. Have membership and/or leadership experience in campus or professional organizations.
5. Submit copy of resume.
6. Submit copy of transcript.
7. A copy of your portfolio/sample of a school project you are most proud of.
8. Complete an application and include a 250-word minimum essay answering the questions below:
What are your career aspirations beyond graduation? **AND** How do you see ASID contributing to your professional development?
9. Become an active member in the committee of their choice for the duration of the scholarship award.

No member of the ASID NJ Chapter Board of Directors, or his or her immediate family, shall be eligible for scholarship assistance during his or her tenure on the ASID NJ Chapter Board of Directors. The Steven Levy and Pat Montalbano ASID NJ Emerging Professionals Scholarship Fund Committee retains the right to withhold scholarship grants in any year if no candidate is determined to be qualified.* The ASID NJ Chapter shall notify the chosen scholarship recipient(s) (up to 3) of its decision and publish on all ASID NJ Chapter social media platforms. Scholarship recipients will be announced on April 4, 2022. All scholarship checks will be made payable to ASID directly for the student.
